IT IS ORDERED BY CONSENT THAT:

- 1. The Claimants have permission:
 - a. To amend the Amended Claim Form to join Brankesmere Limited as a Fifth Defendant and to make the amendments to the Amended Claim Form set out in the draft exhibited to the Application; and
 - b. To amend the Particulars of Claim in the form set out in the draft exhibited to the Application.
- 2. The Claimants shall file and serve the Re-Amended Claim Form and Amended Particulars of Claim within 14 days of receipt of a sealed copy of this Order.
- 3. The First to Fourth Defendants have permission to make amendments to their Defences consequential upon the amendments to the Particulars of Claim. Any such amended Defence is to be filed and served by 4:00 pm on 10 December 2021.
- 4. The Claimants have permission to make amendments to their Replies to the Defences of the First to Fourth Defendants consequential upon the amendments to the First to Fourth Defendants' Defences. Any such amended Replies shall be filed and served by 4:00 pm on 14 January 2022.
- 5. The Fifth Defendant shall file and serve its Defence to the Amended Particulars of Claim by 4:00 pm on 10 December 2021.
- 6. The Claimants shall file and serve any Reply to the Defence of the Fifth Defendant by 4:00 pm on 14 January 2022.
- 7. The Claimants and the First to Fourth Defendants will file updated Direction Questionnaires (and in the case of the Fifth Defendant, it shall file a Direction Questionnaire) by 4:00 pm on 14 January 2022.
- 8. The Claimants will take steps to list a Case Management Conference to be listed with a time estimate of 1 day on the first available date after 1 February 2022.



- 9. The Claimants shall bear the First to Fourth Defendant's reasonable costs of and occasioned by the amendments to the Particulars of Solaim.
- 10. This Order shall be served by the Claimants on the Defendants.
