CONSENT ORDER

AND UPON the Parties having agreed terms of settlement in a confidential Settlement Deed dated 24 October 2022

BY CONSENT

IT IS ORDERED that:

1. The Freezing Injunction is varied such that the Defendants are:
 - a. permitted to grant security as set out in Schedule 1 hereto in favour of the Claimants
 - b. permitted to grant any other security in respect of the properties set out in Schedule 1 with the written Agreement of the Second, Third or Fourth Claimants



- c. permitted to sell any of the properties set out in Schedule 1 hereto with the written agreement of the Second, Third or Fourth Claimants, to redeem any security in respect thereof and to pay any sums that are permitted under the terms of the confidential Settlement Deed.
- d. permitted to make payments to the Claimants.

2. No order as to costs.
